PURPOSE

The purpose of this Operations Issuance is to announce the revision and updates to the San Diego Workforce Partnership (SDWP)'s Operations Manual, <u>Chapter IV</u>, <u>Part 1 Adult and Dislocated Worker Program Activities and Chapter 4</u>, <u>Part 2 Youth Program Activities</u>. Chapter 4 has been revised to incorporate the new Workforce Innovation and Opportunity Act (WIOA) program elements and other updated policies.

BACKGROUND

The purpose of each <u>Chapter 4</u> is to provide local Youth Program Providers, Americas Job Center of California (AJCCs) operators and any other Service Providers (Operators and Service Providers) funded with WIOA Title 1 funds guidance in operating and managing the programs. This guidance will be based on the WIOA legislation, U.S. Department of Labor (DOL) directives in the form of the WIOA Notice of Proposed Rulemaking (NPRMs), the WIOA Final Rules, Training and Employment Guidance Letters (TEGLs) and State of California Employment Development Department (EDD) Directives related to these programs. If necessary, SDWP's Operation Manual and all related directives may be updated at any time upon further guidance from the DOL, EDD or SDWP.

ACTION

Chapter 4, Part 1 and 2 is effective immediately. It supersedes and replaces the stand-alone Operations Issuances listed below, as these have been incorporated throughout the chapters and provided as attachments. In addition, the Chapter now provides direct links to various internet sites, as well as the chapters of the Operations Manual that are referenced throughout the document.
