Do some research

 Use Career Coach at workforce.org/careercoach to explore which occupations align with your interests, see a behind-the-scenes peek at what a career looks like and discover local employers.

Expand your network

- Use social media tools like LinkedIn to network with professionals. Request an informational interview to ask them about their career path, education and job responsibilities.
- Go to local council meetings to network with city professionals.

Get hands-on experience

- Visit SanDiego.gov to learn about internships, mentorships and job shadowing opportunities with the **City of San Diego**.
- Volunteer to be a poll worker on election days for San Diego County at sdvote.com.

Get training

- Paralegal: Get certified through UCSD Extension programs.
- · Firefighters: Get training through Palomar College.
- Consider degree programs at the SDSU School of Public Affairs or one of our other 4-year universities.
