## Item #4: CEO Report

### Informational Item (No Action Required):

Interim President & CEO Tony Young to provide an update on staffing changes across departments including current status of Executive level positions and centralization of Compliance & Operations teams.

- T. Young to also provide update on known issue of backlog in processing of new program and training applicants through Career Centers and will highlight next steps in process to address the issue with due care and diligence.
- T. Young to also discuss the upcoming recommendation that will come to the full WDB at the next meeting to amend the organizational bylaws starting with Article X, amending the need for two-thirds of the entire Board to be required for amending the bylaws and instead, having a majority (51%) of quorum to be allowed to vote. Also, recommendation to remove the required 15 days' notice period and instead follow standard Brown Act requirements.

The next WDB meeting is anticipated to include an informational update on WIOA to the full Board by our EDD Regional Advisor.
